## **League Competition Committee**

### **LEAGUE COMPETITION COMMITTEE**

The League Competition Committee is responsible for the Outdoor Summer League. All decision will be made by this Committee and present to the Board of Directors for ratification. Once ratified, the Summer League will abide by all decisions.

Any changes or amendments after ratification will require a full meeting of this committee with minutes of any changes. The Board of Directors will then ratify the changes.

- a) This Committee will comprise of:
  - i. Representatives from each division. The formula is number of teams in each division divided by 3. Only whole numbers will be used. No fractions
  - ii. Elite = Number of Teams divided by 3
  - iii. Premier = Number of teams divided by 3
  - iv. Division 1 = Number of teams divided by 3
  - v. Division 2 = Number of teams divided by 3
  - vi. Division 3 = Number of teams divided by
  - vii. Recreation Teams 1 representative.
  - viii. Each Division will nominate their delegate the 2<sup>nd</sup> week of January to the 2<sup>nd</sup> week of February to the League Committee in writing to the League Chairman. The League Chairman and League Secretary shall serve on the League Competition Committee. Members of the Board, except the Competition League Chairman and the League Secretary, shall not serve on the League Committee. Members of the executive can attend this meeting as observers. The Chairman and League Secretary shall not propose or second any motion, nor vote on any motion, except in the event of a tie vote, when, despite the provision of clause 19 v) the Chairman may cast a deciding vote.

- ix. If more delegates are interested in serving their respective division, then the vote of the member teams of that division will decide the delegate by vote among themselves, as one vote per team. If result in tie, toss will decide the winner.
- b) Board members or members of other committees cannot represent their teams or divisions at League Committee.
- c) Playing rules for the year will be the responsibility of the Rules Committee. Proposed rules will be rectified by Board.
- d) The Rules Committee will comprise 5 registered members with a minimum of 10 years' experience each, playing in the ASSOCIATION Summer League. One member of this committee must be from the Umpire association and one from the Recreational teams. All committee members must be familiar with current ICC playing rules and conditions for the format being played in Manitoba. The League Committee will select the Rules Committee.
- e) The League Committee chairman shall arrange the schedule of matches and implement the Rules of play as proposed by the Rules Committee.
- f) Any Representative matches will be the responsibility of the Executive Board.
- g) The League Committee or a quorum of this Committee shall arbitrate in all matters pertaining to league competitions. Any disciplinary actions that arise from the League will be dealt with by referring to the Complaint and Disciplinary Policies of the ASSOCIATION
- h) Decisions made by the League Committee shall be reported to the Executive for ratification. In particular, the League Committee shall report to the Executive no later than April 30<sup>th</sup>, their proposed Schedule of matches and local Rules of play.
- i) Maximum one member per club can serve on league committee.
- j) A quorum of the League Committee shall be one member from each of a minimum of two thirds of the registered divisions.

k) Proxy voting is not allowed.
